BY-LAWS

Adopted by the Board of Directors
November 8, 1934

ARTICLE I

Membership

Section 1. Eligibility. Males of the age of twenty-one years or more, and of good moral character, who are in any manner part of the oil and/or gas industry, shall be eligible to membership in the Club.

Sec. 2. Classes of Membership. There shall be three classes of membership, active voting, active non-voting, and associate. Active voting members shall consist of those who reside in Dallas County, Texas, who are in any manner part of the oil and/or gas industry, and they shall be the only members with right and power to vote upon and participate in the control and operation of the Club. Active non-voting members shall consist of those who reside in Dallas County, Texas, and who are not in any manner part of the oil and/or gas industry, who became members of the Club on invitation extended by the Board of Directors of the Club. Such members shall not have any right to vote upon and participate in the control and operation of the Club. Active non-voting members shall pay the same membership fee and dues as are stipulated to be paid by active voting members. Associate members shall consist of those who do not reside in Dallas County, Texas, and they shall not have any right to vote or participate in the control or management of the Club.

Sec. 3. Additional Qualifications. To qualify for membership in the Club all applicants must pay a membership fee in an amount as may from time to time be designated by the Board of Directors.

Sec. 4. Application for Membership. Each

applicant for membership shall present to the Secretary for submission to the President an application in writing, stating his name and address, signed by the applicant himself and by two active members of the Club, neither of whom shall be a member of the membership committee, accompanied by check for the membership fee and for the dues for the first quarter. All applications shall forthwith be delivered by the Secretary to the President.

Sec. 5. Posting and Approval. The name of each applicant for membership, duly proposed and seconded, shall be posted by the Secretary upon the bulletin board of the Club for a period of ten days at the expiration of which time his application shall be submitted by the President to the membership committee. No applicant shall become a member of the Club until his application has been approved by the membership committee, which said approval shall be communicated to the President by said membership committee in such form and manner as the President may direct.

Sec. 6. Notification. On the election of an applicant the Secretary shall notify him of that fact. Upon compliance with all terms and conditions his name shall be entered by the Secretary upon the list of members of the Club.

Sec. 7. Limitation of Membership. Until otherwise provided by resolution of the Board of Directors the active voting and non-voting membership shall be limited to 175, and the associate membership shall be limited to 50. The active non-voting membership shall never exceed twenty-five members.

Sec. 8. Waiting List. When the limit of membership fixed by the Board of Directors shall have been reached, the names of all applicants for membership shall be placed upon a waiting list and thereafter as vacancies occur in the membership of the Club the names of the applicants shall be submitted to the member-

ship committee in the order in which their names appear upon said waiting list.

Sec. 9. Suspension or Expulsion. Any member may be suspended or expelled for sufficient cause by a two-thirds vote of the members of the Board of Directors. The determination of the Board of Directors as to the sufficiency of the cause therefor shall be final.

Sec. 10. Resignation. Any member of the Club may resign from membership by writing delivered to the Secretary; provided, however, that no resignation shall become effective until all current dues and indebtedness to the Club shall have been discharged by such resigning member.

Sec. 11. Effect of Death, Resignation or Expulsion. Upon the resignation, death of expulsion of a member, all of his rights and interest in the property of the Club shall cease.

Sec. 12. Membership Card. Evidence of membership in the Club shall consist of a membership card signed by the President and countersigned by the Secretary and delivered to each member upon his election to membership.

ARTICLE II

Meetings of Members

Section 1. Annual Meetings. The regular annual meeting of the members of the Club shall be held on the second Thursday in January of each year at the hour of eight o'clock p. m.

Sec. 2. Presiding Officer. The President, or in his absence the Vice-President, or any five members of the Board of Directors, may call a special meeting of the members of the Club at any time.

Sec. 3. Special Meetings. Upon written request of twenty-five members, the Board of Directors shall call a special meeting of the members of the Club. Such request for a special meeting and the notice of it shall state the subject for which the meeting is called and at such special meeting no subject shall be considered unless so stated.

Sec. 4. Quorum. At any meeting of the Club, twenty-five members of the Club, not counting members of the Board of Directors, shall constitute a quorum. If at any meeting there be not a quorum present the members present may adjourn to another day.

Sec. 5. Place of Meetings. All meetings of the members of the Club shall be held in the Club rooms. However, for reasons sufficient to the Board of Directors, a meeting or meetings may be held elsewhere, in which case the Board of Directors shall designate the place of the holding of such meeting or meetings.

Sec. 6. Notice of Meetings.

(a) **Annual Meetings.** Notice of the annual meeting shall be mailed, postage prepaid by the Secretary, to each member of the Club, at least ten days before such meeting stating the time and place thereof.

(b) **Special Meetings.** Notice of all special meetings shall be mailed, postage prepaid, by the Secretary to each member of the Club, at least five days before such meeting, stating the time and place thereof.

Sec. 7. Adjournment. A meeting held pursuant to an adjournment of more than three days shall be regarded as a special meeting; but no notice thereof need be given to any member who was present at the adjourned meeting.

Sec. 8. Order of Business. The order of business at the annual meeting shall be as

follows: (a) Reading of the minutes of the last annual meeting and any and all special meetings held subsequent thereto; (b) Report of officers; (c) Reports of committees; (d) Unfinished business; (e) New business; (f) Report of Judges of Election; (g) Adjournment.

ARTICLE III

Election of Board of Directors

Section 1. Number and Term of Office. The Board of Directors shall consist of twelve (12) active members of the Club, four of whom shall be elected each year for a term of three years. Upon occurrence of a vacancy in membership of the Board, the person appointed by the Board to fill such vacancy and the person thereafter elected to fill such vacancy pursuant to the provisions of Sec. 5, Article IV of these By-Laws, shall in succession serve only during the unexpired portion of the term of the director who shall have ceased to function. Upon expiration of the term of office of any director, he shall be ineligible to membership on the Board during a period of twelve months immediately thereafter.

Sec. 2. Nominating Committee. At the regular meeting of the Board of Directors in November of each year there shall be appointed by said Board of Directors a Nominating Committee consisting of three active Club members, none of whom shall be officers of the Club or members of the Board. The names of the Nominating Committee shall be immediately posted upon the Club bulletin board and it shall be its duty to nominate from the active Club membership the proper number to fill the vacancies on the Board of Directors caused by the expiration of term, for the ensuing year. The names of the nominees shall be posted on the Club bulletin board for a period of fifteen days prior to the date of the annual meeting, together with a statement of said nomination signed by a majority of the nominating committee.

Sec. 3. Nomination by Members. Ten or more active members of the Club, who are not members of the nominating committee, nor of the Board of Directors, may also nominate candidates for vacancies on the board of Directors. Such nominations shall be in writing and shall be delivered to the Secretary at least fifteen days before the date of the annual election. It shall be the duty of the Secretary to post the names of said nominees on the Club bulletin board ten days before the date of the annual election, together with a list of the nominating members and a certificate signed by the Secretary that such nominations have been duly made in accordance with the provisions of these By-Laws.

Sec. 4. Declaration of Nominee. If, after such nominations have been posted, any nominee notifies the Secretary that he declines to be a candidate, notice of such fact shall be posted upon the bulletin board and such member shall not be regarded as a nominee; thereupon such vacancy in the list of nominees shall be filled by the body who nominated the declining nominee in the form and manner provided by these By-Laws, as near as may be.

Sec. 5. Ballot. When the time has expired within which such nominations may be made, the Secretary shall cause the names of all the properly nominated and eligible candidates to be printed upon one ballot in alphabetical order and shall mail said ballot to each active member ten days before the annual election.

Sec. 6. Qualification of Voters and Method of Election. The ballots only of active members in good standing as shown by the official list of the Secretary shall be counted. Each member voting shall place a mark on the official ballot opposite the names of the candidates for whom he desires to vote and shall sign his name thereto. Each member who votes may personally deliver his ballot to the Judges

of Election while the polls are open or may mail it in an envelope addressed to the Secretary of the Club, marked "Ballot," to be opened by the Judges of Election upon the day of the election. All ballots cast by mail shall be in the hands of the Secretary before the close of the polls and shall be by him deposited in the ballot box before it is opened by the Judges of Election. If it shall appear on any ballot that any member has voted for more candidates than there are vacancies on the Board of Directors, or has accumulated his vote on one or more candidates, his ballot shall be rejected by the Judges of the Election.

Sec. 7. Judges of Election. Four days prior to each annual election the President shall appoint three members of the Club to be designated as "Judges of the Election," none of whom shall be officers of the Club, members of the Board of Directors nor of any standing committee, whose duty it shall be to receive and canvass all votes and to present to the members of the Club, at the annual meeting, a written report showing the result of the election.

Sec. 8. Polls. The polls shall be open at the Club House for the election of the Board of Directors on the second Thursday in January of each year from the hour of eight o'clock A. M., until the hour of eight o'clock P. M.

Sec. 9. Determination of Election. The number of candidates necessary to fill the vacancies on the Board of Directors receiving the highest number of votes shall be declared elected and shall serve until their successors shall have been duly elected and shall have qualified. In case two or more candidates receive the same number of votes, it shall be determined by lot at the annual election which one be declared elected.

ARTICLE IV

Board of Directors

Section 1. Election of Officers. The Board of Directors shall meet at the Club rooms at noon on the day following the annual meeting of the members of the Club and shall elect from their number a President and Vice-President; and shall elect a Secretary and a Treasurer from the active membership of the Club, who may or may not be members of the Board; all to serve until the next annual meeting of the members of the Club and until their respective successors shall have been duly elected and shall have qualified. The Board of Directors shall have power to appoint an Assistant Secretary or an Assistant Treasurer, or both, who may not be active members of the Club, to serve at the will of the Board, at such salary or salaries as may be fixed. One person can fill offices of Secretary and Treasurer.

Sec. 2. Regular Meetings. The Board of Directors shall hold a regular monthly meeting on the second Friday of each month at twelve o'clock noon, for transaction of the business of the Club.

Sec. 3. Special Meetings. A special meeting of the Board of Directors may be held at any time or place, in the City of Dallas, upon the call of the President, or upon the call of five members of the Board of Directors, upon twelve hours notice given by the Secretary of the time and place and object of such meeting.

Sec. 4. Quorum. A Quorum of the Board of Directors shall consist of seven (7) members thereof.

Sec. 5. Duties of the Board of Directors. The Board of Directors shall have general charge of the affairs, funds and property of the Club and shall have full power to carry out the purposes of the Club according to its charter and By-Laws.

It shall keep a record of all its official acts and make a report of the same at the annual meeting of the Club.

It shall have power to fill vacancies upon the Board of Directors by majority vote and the person or persons appointed to fill such vacancy shall serve until the next annual meeting of the members of the Club, at which meeting the vacancy or vacancies shall be filled by election as hereinbefore provided.

It may appropriate and expend the monies of the Club from time to time in furtherance of its objects, and audit and approve bills for the same, which approval shall be evidenced by the signature of its Chairman.

Sec. 6. Suspension and Expulsion. The Board of Directors shall have power by vote of two thirds of all the members thereof (a) to remove any officer of the Club for cause; (b) to suspend or expel any member for non-payment of dues or other indebtedness due by him to the Club; (c) to reprimand, suspend or expel any member guilty of any violation of the By-Laws or house-rules of the Club, or for conduct unbecoming a gentleman, or for other good and sufficient cause; or for any offense against the interests of good government of the Club.

A copy of the charges preferred against any officer or member shall be served upon him at least ten days before the meeting of the Board of Directors at which such charges shall be considered, together with a notice of the time and place of the meeting, at which meeting he shall have an opportunity to be heard in his defense.

The determination of the Board of Directors as to the sufficiency of the cause for removal or suspension shall be final.

Sec. 7. Construction of By-Laws. The Board of Directors shall determine the construction to be placed on these By-Laws or on any part or parts thereof which may be in conflict or doubtful meaning.

ARTICLE V

Duties of Officers

Section 1. President. The President shall be Chairman of the Board of Directors and shall preside at all meetings of the members of the Club and of the Board of Directors. In his absence or inability to act, the Vice-President shall perform his duties.

Sec. 2. Secretary. The Secretary shall keep a record of all the meetings of the members of the Club and of the Board of Directors; he shall give notice of all regular and special meetings of the members of the Club and to the members of the Board of Directors of all meetings of said Board; he shall have the custody of the seal of the Club and shall keep a record of all the officers and members thereof and of their addresses; he shall notify new members of their election; he shall also be charged with the performance of any duties in these By-Laws imposed upon him.

Sec. 3. Treasurer. The Treasurer shall (a) collect, hold, and disburse, under the direction of the Board of Directors of the Club, all monies of the Club; (b) be charged with the duty of collection of all money due the Club from members thereof and all other sources; (c) keep or cause to be kept, regular book of accounts and submit a statement of his accounts at the monthly meeting of the Board of Directors; (d) exhibit to the Board of Directors before each annual meeting, a full account of the receipts and disbursements during the fiscal year last past, in which the items shall be given in detail, particularly showing the

sums received from members and the account on which the same were paid; of all disbursements made during the fiscal year, which disbursements shall be supported by vouchers. The Board of Directors shall examine said report and vouchers therewith submitted, and if found correct shall present it to the Club at its annual meeting in connection with their report; (e) upon request from the Board of Directors, fully report the status of all members of the Club, stating who has been, or is, under suspension for delinquency, and who, if any, has by delinquency, subjected his membership to forfeiture. He shall also upon request of the Board, report a statement of all amounts due from members, specifying what assessments remain unpaid by each member, and the reason for its not having been collected; (f) shall keep the books in which he shall record all suspensions of the credit of members for non-payment of dues or other money due and date thereof; (g) deposit all monies of the Club in the name of the Club with some bank or banks in the city of Dallas to be designated by the Board of Directors; (h) give a bond for the faithful performance of his duties in the amount, in the form and with sureties, to be approved by the Board of Directors.

ARTICLE VI

Standing Committees

Section 1. Appointment by President. At the first meeting of the Board of Directors each year after the regular annual meeting of the Club, the President, with the consent and approval of the Board of Directors, shall appoint the following standing committees to serve for a term of one year or until their successors are appointed.

1. A Membership Committee.
2. A House Committee.
3. A Finance Committee.

Sec. 2. Membership Committee.

(a) Composition. The Membership Committee shall be composed of five active members of the Club, of which committee the President shall not be a member. The personnel of the committee shall be secret and known only to the President and the members of the committee.

(b) Duties of Membership Committee. It shall be the duty of the President to refer to the membership committee all applications for membership in the Club. It shall be the duty of the membership committee to pass upon the eligibility of such applicants. The proceedings of the membership committee shall be secret and confidential and shall not be communicated by the members of that committee to the President nor to any other person whomsoever. An applicant who has not received the unanimous vote of the membership committee shall not be reported by the membership committee to the President as having been elected to membership in the Club. The result of the determination of each applicant shall be communicated by the membership committee to the President in such form and manner as may be by the President and said membership committee provided.

Sec. 3. House Committee.

(a) Composition. The House Committee shall be composed of five active members of the Club, one of whom at least shall be a member of the Board of Directors.

(b) Duties. The House Committee shall have general charge and supervision of the Club House and shall be charged with the duty of promulgating house-rules and of enforcing the same. It shall have the power to fix the price for all supplies furnished, to investigate and redress complaints duly brought to its attention by letter, and to employ and discharge all house-employees.

It shall report to the Board of Directors all violations of the House-rules by the members of the Club and to recommend to the Board of Directors the punishment to be inflicted for the violation thereof.

Sec. 4. Finance Committee.

(a) **Composition.** The Finance Committee shall be composed of five active members of the Club, one of whom at least shall be a member of the Board of Directors.

(b) **Duties.** The Finance Committee shall audit, or cause to be audited, from time to time, the account of the Treasurer, and shall direct the financial policy of the Club, subject to the approval of the Board of Directors. It shall also have such other powers and duties as the Board of Directors, may from time to time, prescribe.

ARTICLE VII

Fees and Dues

Section 1. Fees. The Board of Directors shall, from time to time fix the fee to be paid for membership in the Club.

Sec. 2. Annual Dues. The annual dues of members shall be in the amount designated by the Board of Directors, payable quarterly in advance on the first days of January, April, July and October, respectively, of each year.

Sec. 3. Payment of Indebtedness; suspension of Credit. On or before the fifth day of each month a statement shall be mailed by the Treasurer or Assistant Treasurer to each member showing his indebtedness to the Club, including dues, on the first day of said month, with the request that he pay the same. If such indebtedness be not paid on or before the twentieth day of the month, the name of such member shall be posted on the bulletin board of the Club with the amount of his indebted-

ness set opposite his name, and thereafter such member shall not be entitled to the privileges of the Club House and shall receive no further credit until his indebtedness shall have been paid in full. If such indebtedness remains unpaid after posting for a period of thirty days, the Board of Directors may, by resolution, expel such member from the Club.

Sec. 4. Limitation of Credit. Whenever a member's indebtedness to the Club for house bills shall have reached the sum of One Hundred (\$100.00) Dollars, his further credit may be suspended by order of the House Committee until the entire amount due by him shall have been paid.

ARTICLE VIII

Visitors

Section 1. Non-Residents. Persons residing outside of Dallas County may be introduced into the Club as guests upon the request of any member and may have issued to them upon such request, a card of privileges which shall be limited to a period of ten days. No member shall be allowed more than three such cards at any one time.

Sec. 2. Residents. A resident of the City of Dallas, Texas, may be introduced into the Club as a guest, by card, but no resident shall be so introduced oftener than once a year, except upon special invitation of the Club.

Sec. 3. Indebtedness of Visitors. A member introducing a visitor shall be held responsible for his indebtedness to the Club.

Sec. 4. Members of Family of Active Club Members. Wives, sons under the age of twenty-one years, and unmarried daughters who form a part of an active member's household, shall be entitled to such privileges as may be fixed by the House Committee. The member to whose household such persons belong shall be responsible for the payment of any indebtedness incurred by them.

ARTICLE IX

Miscellaneous

Section 1. Fiscal Year. The fiscal year of the Club shall begin on the first day of the month of January of each year and close on the 31st day of December in each year.

Sec. 2. Intoxicating Liquor. The introduction of intoxicating liquor onto the Club premises and the use thereon in violation of Federal, State or local laws, is prohibited. The penalty for the violation of this Section of the By-Laws shall be the expulsion of the offending member.

Sec. 3. Gambling. Gambling, in all of its forms, is prohibited. The playing of cards and other games as a social diversion will be permitted under the supervision of the House Committee.

Sec. 4. Bulletin Board. A Club bulletin board shall be placed in a permanent place in the Club rooms. Nothing shall be posted on the bulletin board, except by officers of the Club, by the Board of Directors, or by the standing committees.

Sec. 5. Amendments. The By-Laws of the Club may be modified or repealed at any regular meeting of the Board of Directors by a majority vote thereof; provided, however, that the proposed amendment shall have been submitted to and read at the preceding meeting of the Board of Directors; or the By-Laws may be amended at any regular meeting of the Board of Directors without previous notice, by a two-thirds vote of the whole Board of Directors, and shall become effective after ten days notice shall have been given by the posting of the amendment on the bulletin board of the Club.
